Richard East; Sue Prevezer; John Quinn Stellar doesn't even come close

This all-litigation firm has become a byword for quality globally. Quinn became the second most profitable firm in the world in 2010 and it cemented its position at the top end of the market by reporting firm-wide revenues of \$723m in 2011, an increase of 31% – an astonishing journey from its humble West-Coast beginnings that saw the founding partners pounding the streets for work in 1986. It now boasts an unrivalled 91% trial and arbitration success rate and over 600 lawyers in 10 offices across the world. The twin pillars of IP and financial services litigation serve it very well in these markets and, not content with blazing a trail in the US, the firm has opened a second office in Germany and another in Moscow in the last 12 months.

Since its first full financial year in 2009, the City office has only known growth. The office grew its revenues from £7.6m to £12.4m from 2009 to 2010. The firm has just reported London revenues of around £21.8m during the 2011 calendar year, up 75%.

As one rival recently told us: 'Ultimately, who am I scared of most when we go to pitch? It is Quinn Emanuel because of what they have done and what they can do.'


