At the forefront of a transformative and successful year

The past year has been a busy one for Telefónica UK's legal department. Led by general counsel Ed Smith, it has scored some impressive triumphs during 2012 against the backdrop of a global reorganisation of the legal function.

The team at Telefónica has taken on myriad issues during the year, working effectively with external counsel to land a number of remarkable wins on or under budget. This has meant that the telecoms giant's legal department has delivered year-on-year cost savings for the business. Standout work includes winning merger clearance from the European Commission with other mobile operators to secure a joint venture; managing the fallout from a major network outage; and negotiating with key stakeholders to secure improved position for the business following the Government's decision to grant EE a period of 4G monopoly.

All this was achieved while the legal function has been reshaped at the telecoms giant. A truly remarkable achievement.

Coming under increased pressure from the boardroom, Colt's general counsel Robin Saphra was tasked with streamlining the company's legal spend. As a result, he whittled down the number of external panel firms Colt uses from over 100 to just one lead adviser. The move saw Baker & McKenzie sign on to a three-year contract worth £3m.

### **CREDIT SUISSE**

Credit Suisse saved several million pounds in legal spend after the in-house team implemented a number of new strategies, including establishing outsourcing arrangements in locations where it previously had no footprint. The bank also recently launched the activity management programme, which is designed to monitor the use of legal resources and to apply alternative solutions where it's needed.
