Becoming a champion for employees with disabilities

This firm has worked particularly hard in recent years to establish itself as the law firm of choice for disabled candidates. In 2014 the firm formed a partnership with My Plus Consulting, which specialises in helping organisations to understand and address the issues around disability. The firm has also formed fruitful partnerships with EmployAbility, a not-for-profit organisation dedicated to assisting students and graduates with all disabilities to enter employment, and the Lawyers with Disabilities division of the Law Society.

The effort put in by Reed Smith's Disability Task Force has borne fruit. At the end of August 2014, the firm had received 65 applications from disabled candidates for its summer vacation scheme and 60 applications for training contracts. In 2014 the firm interviewed 13 disabled candidates for its summer vacation scheme and training contracts, offering five places on its summer vacation scheme and making five training contract offers to disabled candidates, all of which were accepted.
