STRENGTH TO STRENGTH FOR THE MIGHTY QUINN Not only was 2015 another exceptional year financially for the firm, with London revenues up a striking 41% to £36.9m, but this top-performing firm has also extended its coverage in the City, launching a London competition practice with the hire of Hausfeld partner Boris Bronfentrinker and a white-collar crime practice with the relocation of US partner Stephen Hauss. It also hired commercial litigation partner Nick Marsh from DLA Piper, bringing the total number of London partners to 14.

Significant cases include representing FIFA in US and Swiss criminal investigations into allegations of bribery and corruption and one of the lead claimant groups in the £4bn RBS rights issue litigation.

Mike Morrison, managing director at KPMG, comments: 'QE has developed its London team in the past year with the addition of a number of senior and well-regarded lawyers... The strengthening of the team has ensured that its strong client service has not been impacted by the firm becoming increasingly a popular alternative to the larger city firms.'
